- * Payment for class(es) are to be made prior to appointment(s)
- * Booking cancelled 24 hours before can be rescheduled at no cost.
- * Bookings cancelled within 24 hours incurs 50% of the class fee.

Bali Retreat 2019

- * A registration deposit of \$400 per person is required to hold a place & block accommodation at the retreat venue. From July 18, 2019 all deposits are non-refundable and non-transferable.
- * A refund or transfer of 50% of the deposit is applicable if a registration for the 2019 retreat is cancelled before July 18, 2019. No refunds or transfers of deposits will be given if cancellation is within 9 weeks (after July 18, 2019) of the retreat start, October 18, 2019.
- * Airfares are not included in the quoted costs and are the participant's responsibility.
- * In the event of the retreat being cancelled by the organiser or the participant cancelling, no responsibility will be taken for airfares booked.
- * It is the participant's responsibility to arrange travel insurance and any required vaccinations for overseas if desired.
- * For legal reasons, you must ensure that you have at least six months remaining on your passport. Indonesian officials are very strict on this rule.
- * Participants must pay the full fee by September 18, 2019 to confirm their place on the Bali Retreat 2019.
- * Participants must give 5 weeks notice if they are no longer able to attend the Bali Retreat 2019.
- * A refund of fees paid, less deposit amount that is applicable, can be arranged minus a 20% administration fee if sufficient notice of cancellation is provided (five weeks).
- * No refunds will be given if cancellation notification is within 5 weeks of the start date, October 18, of the Bali Retreat 2019. Fees paid are non-transferable and non-refundable after September 18, 2019.
- * If the Retreat is not adequately subscribed the retreat may be cancelled. In this event, the participants will be notified and a full refund will be arranged.

- * In the event of the retreat being cancelled by the organiser or the participant cancelling, no responsibility will be taken for airfares / transport booked.
- * It is the participant's responsibility to arrange travel insurance if required.
